



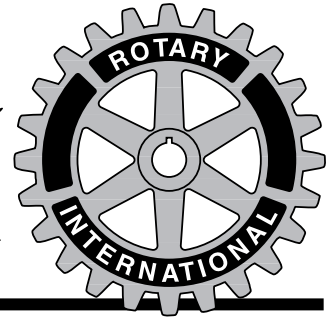

## Welcome to the Rotary Club of New Port Richey

### June 22, 2011

Today we welcome Steve Persall, St. Pete Times movie critic.

### Last Week

Our program last week was Principal Ken Meisner with an update on Richey Elementary School. Ken lives in New Port Richey, has two daughters, and has worked in New Port Richey for the past 18 years. In 2009/2010 he was named Principal of the Year. Ken explained that Richey Elementary was built in 1958 and had some interesting history. There was the clanking 'C' on the sign and the Mulberry trees that the kids used to pick the berries from and throw during recess. The boys used to take their milk cartons out back and collect tadpoles to throw at the girls.

Ken then spoke about the school now. They are a Title 1 school with 86% of the kids on free or reduced lunch. Of the 86%, 81% qualify for free lunch. He said they have a dedicated staff at the school with not much of a turnover. According to FCAT testing, they currently have the highest performance in the county. Ken says that they have great kids and a great staff and that's something New



Port Richey should be proud of.

Ken then spoke about the building of the new Richey Elementary School. The big equipment should be here by the end of July and it should take until October to start building up. The first phase will be 3/4ths of the rectangle which will house classrooms, media and staff. Next summer the cafeteria, music, arts and physical education offices should be done. Then the landscaping phase. Ken said, "I've been told by the architects that this will be the worst two years of my life."

The District does not pay for a playground, which will cost \$60,000. This year they have

raised \$30,000 and the District matched the first \$15,000. Their goal is to raise \$90,000 to include a \$30,000 cover over the playground. Ken said, "I'm pretty confident that we will reach our goal." Allen then announced that our club was donating \$1,000 and that next year the bowls on the table will be there to collect change to donate to Richey Elementary towards their playground.

We would like to thank the Principal Ken Meisner for an interesting and informative program. A book will be donated, in his name, to the PHCC Library.

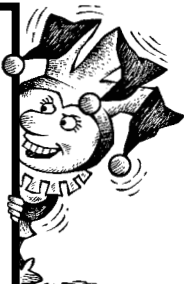
"Well," said the husband, "many years ago a man died in this land and was buried, only to rise from the dead three days later. I really can't take that chance with my wife."

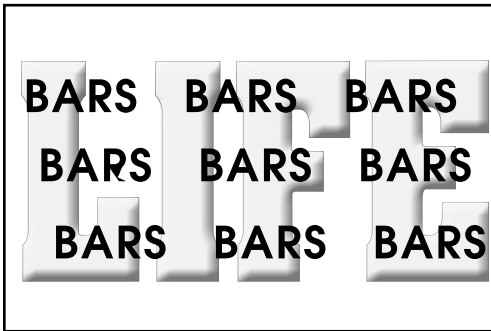

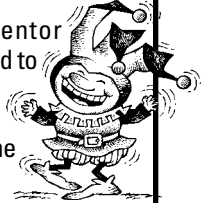
